Since 2009, I have been working at the Civil Aviation Authority of Singapore. I currently lead a team that oversees the licensing of pilots and aircraft engineers. We also oversee the development of regulations and safety policies, as well as ensuring the compliance of pilot and maintenance training organisations. 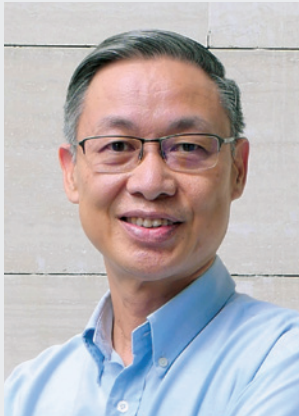
